The City Council of the City of Clinton, Missouri met Tuesday, April 16, 2024. Mayor Carla Moberly presided.

1. Call to Order for Public Hearing: Mayor Carla Moberly opened the Public Hearing at 6:00 p.m.

3. Public Hearing

Public hearing to hear comments regarding a request for a variance from Section 3.A. of the Declaration of Restrictive Covenants:

No building, loading docks or outside storage shall be constructed upon any site within seventy-five (75) feet of any street right-of-way line in existence or proposed by the City or it successor at the time of such construction. No loading docks shall be constructed so as to be at the front of a building or fronting any street.

The City of Clinton, owner of Lot 14-1 (at the time of application), requested a variance to allow a potential buyer of Lot 14-1 to construct a building with a 35-foot set back from the street ROW, due to the location of the floodplain. This proposed building location exceeds the 25-foot I-2 zoning set back requirement. The property was purchased by Bohannan Investments, LLC on April 8, 2024.

City Administrator Christy Maggi represented the City of Clinton, the original applicant, explaining the purpose of the request. There were no other comments. Action will be taken at the next council meeting.

- 11. Committee Reports:
 - a. Public Works Committee Report: Council Person Jackson gave the following committee report:
 - 1. Cemetery:
 - a. McLane Chapel Roof: Delivery of roofing materials is ahead of schedule. Contractor plans on starting Monday, April 29. Will be completed by May 17. City will arrange for a cleaning service to clean the interior of the building after the project is completed. For information only.
 - b. Memorial Day Preparation Schedule: City will solicit quotes for contract mowing assistance for the week before Memorial Day weekend. Council Person Jackson made a motion to solicit quotes for mowing assistance at Englewood Cemetery. Council Person House duly seconded the motion. 8 Ayes; O Nays. Mayor Carla Moberly declared the motion passed.
 - 2. Waste Water: For information only.
 - a. East Digester: Snorkel is damaged. Pump must be used to recant digester. Will evaluate the extent of the damage. UPDATE: Snorkel is broken at flange. Jon is pricing a telescoping, stainless snorkel. Repair can be made by AWR.
 - b. Skimmer Digester Blower: Blower is operational. Changed the oil; now evaluating the belt. Will empty basin in order to re-pipe the digester. Work can be done by AWR. Upon completion, this item can be removed from the items in the WWTP Improvement Project.
 - c. Manhole and Pipelining Rehab: 8 MHs to be rehabbed. Pricing is for a cementitious coating. PWC asked Jon to get pricing for a rubber coating with a longer life cycle. CIPP liner to be installed in 5 separate lines (2,000+/- l.f.). This project is in the FY 23/24 Budget.
 - d. Calvird Pump Station VFD: Upgrade is underway and going well.
 - e. WWTP Improvement Project: Ross Construction is still working on revised pricing for selected project components. More info will be provided at the next Public Works Meeting.
 - f. Ditch Inspection for Sediment: Inspection completed. A small amount of sediment was detected in a few locations. The ditch will not need to be cleaned.

3. Park & Rec:

- a. Artesian Pool Parking Lot Project: Change Order 02 was reviewed and discussed. Christy will sign CO 02 since the revised contract amount is less than the originally approved contract amount. Light poles are in good shape but foundation bases need to be reconstructed. For information only.
- b. Antioch Park installation of culvert and headwalls: Scheduled to begin in late April. Working with MO Dept. on Conservation to revise grant timeline. For information only.

- d. Maintenance Buildings: John McClendon presented estimated costs for the construction of a 40' x 40' x 14' maintenance building. PWC recommends advertising for bids. Current building is not insulated and needs more space to work on vehicles in the winter months. Council Person Jackson made a motion to solicit quotes for new building. Council Person House duly seconded the motion. 8 Ayes; O Nays. Mayor Carla Moberly declared the motion passed.



The Challenge Of Growing Electricity Demand In The US

The shortage of electrical equipment remains a significant bottleneck to utility supply chains

Electricity consumption in the US remained stagnant without significant growth for the past two decades up until 2021, as a growing emphasis on energy efficiency effectively counterbalanced the increasing demand. However, in the last few years we have experienced a swift change in demand landscape, pushing electricity demand back into expansion. Load growth, or the increase in power demand over time, has cast a spotlight on the resilience of utility supply chains with crucial electrical equipment, such as transformers and switchgear, already falling into a shortage, resulting in ballooning prices and escalating lead times.

Catalysts of the Load Growth

Substantial investments in the manufacturing sector, particularly in electrical equipment manufacturing, have been the primary drivers of the turnaround in electricity demand. Construction spend in manufacturing surged by 32% year-over-year in February, a staggering 181% versus prepandemic levels, stimulating greater demand for the underlying equipment. This upswing in manufacturing investment can be largely attributed to the Inflation Reduction Act (IRA) and the CHIPS and Science Act, both of which are channeling investment into domestic supply chains for critical energy transition components, with the IRA already accounting for more than 200 planned manufacturing facilities.

Increasing interest in artificial intelligence (AI) has further amplified the growing electricity demand, with data center electricity consumption projected to escalate from 2.5% of total US consumption in 2022 to 7.5% by 2030, which is roughly 130 terawatts per hour (TWh) to 390 TWh.

One of the challenges associated with manufacturing and data centers is that they typically require round-the-clock power, something that traditional renewable generation, such as solar and wind, cannot consistently meet. In addition, factors such as the accelerated rollout of electrical vehicles (EVs), the establishment of hydrogen hubs, and heightened peak demand from high temperature and extreme weather events, all contribute significantly to the burgeoning electricity demand landscape.

Supply Chain Weaknesses Exposed

The return of load growth comes with many impacts, most notably the heightened stress on the supply chains of key equipment, which are already struggling to fulfill the ballooning demand. Concerns also remain over the capabilities of the existing transmission and distribution (T&D) infrastructure and its ability to handle the expanding capacity.

Over the past few years, transformers have emerged as a significant bottleneck to utility supply chains as demand outpaces available supply, with only 20% of US demand being met by domestic supply. The shortage is not isolated to the US, but the impacts are more evident due to the lack of local supply chains.

This scarcity has triggered substantial upward price pressures across the transformer market, with prices rising between 40% and 60% since January 2022, depending on the specification. In parallel, lead times for power transformers have escalated significantly from around 78 weeks in Q1 2022 to 127 weeks by Q4 2023. Switchgear and circuit breaker suppliers are already feeling the impact of the heightened demand as lead times continue to swell, with high-voltage circuit breakers recording an average lead time of 151 weeks in Q4, an increase of more than 130% year-over-year.

In addition, the competition for available supply has also pushed prices up, with circuit breakers and medium-voltage switchgear prices estimated to have increased by 21% and 26%, respectively, since January 2022. Demand for electrical equipment, especially switchgear and transformers, is anticipated to remain strong as the investment into manufacturing facilities and datacenters continues to ramp up, while utilities are expected to respond to the increasing electricity demand by expanding generation capacity and bolstering the T&D infrastructure. Robust demand is expected to persist for the foreseeable future, keeping both lead times and prices elevated.

Barriers to Meeting Rising Demand

The shortage of domestic capacity and the growing lead times for key equipment raises a key question: why is domestic supply not expanding to help meet the growing demand? Ultimately, the technical manufacturing processes that are required create extremely high barriers of entry for suppliers. Additionally, the surge in demand for electrical equipment may only last for a few years, which makes suppliers hesitant to invest in greater supply capabilities that could result in over-supply conditions when demand eases. This phenomenon mirrors past experiences in markets like semiconductors, where short-term market booms led to increased capacity, only to face challenges when the market dynamics shifted.

Overall, the rapid expansion of energy-intensive infrastructure is expected to continue fueling load growth over the coming years, putting additional strain on supply chains. These dynamics highlight the importance of fortifying domestic supply for crucial equipment rather than heavily relying on foreign imports.

The industry could also see increased resistance to clean energy goals due to the lead times to build clean generation sources and transmission interconnection delays, with the increasing demand likely to require pre-existing fossil fuel generation to meet load demand. As the energy landscape continues to evolve, a balance will need to be struck to ensure clean energy infrastructure continues to expand while meeting the expanding energy demand.





Assignment. For valuable consideration, Lessee hereby assigns, grants a continuing security interest in, and conveys to Lender all of Lessee's right and interest in and to the Lease and Agreement dated June 17, 2008 amended April 16, 2013 and amended November 21, 2023 made and executed between the City of Clinton, Missouri, a Municipal Corporation and the Clinton Airport Association, Inc, a Non-profit Missouri Corporation.

Future Advances. In addition to the Note, this Assignment secures all future advances made by Lender to Grantor whether or not the advances are made pursuant to a commitment. Specifically, without limitation, this Assignment secures, in addition to the amounts specified in the note, all future obligations of Grantor to Lender and all future amounts Lender in its discretion may loan to Grantor, together with all interest thereon.

This Assignment is given to Secure (1) Payment of the indebtedness and (2) performance of any and all obligations of Grantor under the note, this assignment, and the related Documents. This Assignment is Given and accepted on the following terms:

PAYMENT AND PERFORMANCE. Except as otherwise provided in this Assignment or any Related Documents, Grantor shall pay to Lender all amounts secured by this Assignment as they become due, and shall strictly perform all of Grantor's obligations under this Assignment. Unless and until Lender exercises its right to collect the Subsidy as provided below and so long as there is no default under this Assignment, Grantor may remain in possession and control of and operate and manage the Property and collect the Subsidy, provided that the granting of the right to collect the Subsidy shall not constitute Lenders consent to the use of cash collateral in a bankruptcy proceeding.

GRANTOR'S REPRESENTATIONS AND WARRANTIES. Grantor warrants that:

Ownership. Grantor is entitled to receive the Subsidy free and clear of all rights, loans, liens, encumbrances, and claims except as disclosed to and accepted by Lender in writing.

Right to Assign. Lessee/Lessor jointly have the full right, power and authority to enter into this Assignment and to assign and convey the Assignment and Agreement to Lender.

No Prior Assignment. Lessee/Lessor jointly have not previously assigned or conveyed the Lease and Agreement to any other person by any instrument now in force.

No Further Transfer. Grantor will not sell, assign, encumber, or otherwise dispose of any of Grantor's rights in the Lease and Agreement except as provided in this Assignment.

LENDER'S RIGHT TO RECEIVE AND COLLECT THE SUBSIDY. Lender shall have the right at any Time, and even though no default shall have occurred under this Assignment, to collect and receive the Subsidy. For this purpose, Lender is hereby given and granted the following rights, powers and authority:

Notice to Lessor. Lender may send notices to the Lessor of the Property advising them of this Assignment and directing all Subsidy payments to be paid directly to Lender or Lender's agent. **Compliance with Laws.** Lender may do any and all things to execute and comply with the laws of the State of Missouri and also all other laws, rules, orders, ordinances and requirements of all other government agencies affecting the Property.

Other Acts. Lender may do all such other things and acts with respect to the Property as Lender may deem appropriate and may act exclusively and solely in the place and stead of Grantor and to have all of the powers of Grantor for the purposes stated above.

No Requirement to Act. Lender shall not be required to do any of the foregoing acts or things, and the fact that Lender shall have performed one or more of the foregoing acts or things shall not require Lender to do any other specific act or thing.

APPLICATION OF SUBSIDY. All costs and expenses incurred by Lender in connection with the Property shall be for Grantor's account and Lender may pay such costs and expenses from the Subsidy. Lender, in its sole discretion, shall determine the application of any and all Subsidy Payments received by it; however, any such Subsidy Proceeds received by Lender which are not applied to such costs and expenses shall be applied to the indebtedness. All expenditures made by Lender under this Assignment and not reimbursed from the Subsidy Proceeds shall become a part of the indebtedness secured by this Assignment, and shall be payable on demand, with interest at the Note rate from date of expenditure until paid.

FULL PERFORMANCE. If Grantor pays all of the Indebtedness when due and otherwise performs all the obligations imposed upon Grantor under this Assignment, the Note, and the Related Documents, Lender shall execute and deliver to Grantor a suitable satisfaction of this Assignment and suitable statements of termination of any financing statement on file evidencing Lender's security interest in the Subsidy Proceeds and the Property. Any termination fee required by law shall be paid by Grantor, if permitted by applicable law.

DEFAULT. Each of the following, at Lender's option, shall constitute an Event of Default under this Assignment:

Payment Default. Grantor fails to make any payment when due under the indebtedness. **Other Defaults.** Grantor fails to comply with or to perform any other term, obligation, covenant or condition contained in this Assignment or in any of the Related Documents or to comply with or to perform any term, obligation, covenant or condition contained in any other agreement between Lender and Grantor.

Default on Other Payments. Failure of Grantor within the time required by this Assignment to make any payment for taxes or insurance, or any other payment necessary to prevent filing of or to effect discharge of any lien.

False Statements. Any warranty, representation or statement made or furnished to Lender by Grantor or on Grantor's behalf under this Assignment or the Related Documents is false or misleading in any material respect, either now or at the time made or furnished or becomes false or misleading at any time thereafter.

Defective Collateralization. This Assignment or any of the Related Documents ceases to be in full force and effect (including failure of any collateral document to create a valid and perfected security interest or lien) at any time and for any reason.

Property Damage or Loss. The Property is lost, stolen, substantially damaged, sold, or borrowed against.

Adverse Change. A material adverse change occurs in Grantor's financial condition, or Lender believes the prospect of payment or performance of the indebtedness is impaired.

RIGHTS AND REMEDIES ON DEFAULT. Upon the occurrence of any Event of Default and at any time thereafter, subject to Grantor's right to cure, if any, under Missouri law, Lender may exercise any one or more of the following rights and remedies, in addition to any other rights or remedies provided by law:

Accelerate indebtedness. Lender shall have the right at its option without notice to Grantor to declare the entire Indebtedness immediately due and payable, including any prepayment penalty that Grantor would be required to pay.

Collect Subsidy Proceeds. Lender shall have the right, without notice to Grantor, to take collect the Subsidy Proceeds, including amounts past due and unpaid, and apply the net proceeds, over and above Lender's costs, against the indebtedness. In furtherance of this right, Lender shall have all the rights provided for in the Lender's Right to Receive and Collect the Subsidy, above. If the Subsidy Proceeds are collected by Lender, then grantor irrevocably designates Lender as Grantor's attorney-an-fact to endorse instruments received in payment thereof in the name of Grantor and to negotiate the same and collect the proceeds. Lender may exercise its rights under this subparagraph in writing.

Other Remedies. Lender shall have all other rights and remedies provided in this Assignment or the Note or by law.

Election of Remedies. Election by Lender to pursue any remedy shall not exclude pursuit of any other remedy, and an election to make expenditures or to take action to perform an obligation of Grantor under this Assignment, after Grantor's failure to perform, shall not affect Lender's right to declare a default and exercise its remedies.

Attorneys' Fees Expenses. If Lender institutes any suit or action to enforce any of the terms of this Assignment, Lender shall be entitled to recover such sum as the court may adjudge reasonable as attorneys' fees at trial and upon any appeal. Whether or not any court action is involved, and to the extent not prohibited by law, all reasonable expenses Lender incurs that in Lender's opinion are necessary at any time for the protection of its interest or the enforcement of its rights shall become a part of the indebtedness payable on demand and shall bear interest at the Note rate from the date of the expenditure until repaid. Expenses covered by this paragraph include, without limitation, however subject to any limits under applicable law, Lender's attorneys' fees and Lender's legal expenses whether or not there is a lawsuit, including attorneys' fees and expenses for bankruptcy proceedings (including efforts to modify or vacate any automatic stay or injunction), and Appeals, the cost of searching records, obtaining title reports (including foreclosure reports), surveyors' reports, and appraisal fees and title insurance, to the extent permitted by applicable law. Grantor also will pay any court costs, in addition to all other sums provided by law.

MISCELLANEOUS PROVISIONS. The following miscellaneous provisions are a part of this Assignment:

Amendments. This Assignment, together with any Related Documents, constitutes the entire understanding and agreement of the parties as to the matters set forth in this Assignment. No alteration of or amendment to this Assignment shall be effective unless given in writing and signed by the party or parties sought to be charged or bound by the alteration or amendment.

Caption Headings. Caption headings in this Assignment are for convenience purposes only and are not to be used to interpret or define the provisions of this Assignment.

Governing Law. This Assignment will be governed by the federal law applicable to Lender and, to the extent not preempted by federal law, the laws of the State of Missouri without regard to its conflicts of law provisions. This Assignment has been accepted by Lender in the State of Missouri.

Choice of venue. If there is a lawsuit, Grantor agrees upon Lenders request to submit to the jurisdiction of the courts of Greene County, State of Missouri.

Merger. There shall be no merger of the interest or estate created by this Assignment with any other interest or estate in the Property at any lime hold by or for the benefit of Lender in any capacity, without the written consent of Lender.

No Waiver by Lender. Lender shall not be deemed to have waived any rights under this Assignment unless such waiver is given in writing and signed by Lender. No delay or omission on the part of Lender in exercising any right shall operate as a waiver of such right or any other right. A waiver by Lender of a provision of this Assignment shall not prejudice or constitute a waiver of Lender's right otherwise to demand strict compliance with that provision or any other provision of this Assignment. No prior waiver by Lender, nor any course of dealing between Lender and Grantor, shall constitute a waiver of any of Lender's rights or of any of Grantor's obligations as to any future transactions. Whenever the consent of Lender is required under this Assignment, the granting of such consent by Lender in any instance shall not constitute continuing consent to subsequent instances where such consent is required and in all cases such consent may be granted or withheld in the sole discretion of Lender.

Notices. Any notice required to be given under this Assignment shall be given in writing, and shall be effective when actually delivered, when actually received by telefacsimile (unless otherwise required by law), when deposited with a nationally recognized overnight courier, or, if mailed, when deposited in the United States mail, as first class, certified or registered mail postage prepaid, directed to the addresses shown near the beginning of this Assignment. Any party may change its address for notices under this Assignment by giving formal written notice to the other parties, specifying that the purpose of the notice is to change the party's address. For notice purposes, Grantor agrees to keep Lender informed at all times of Grantor's current address. Unless otherwise provided or required by law, if there is more than one Grantor, any notice given by Lender to any Grantor is deemed to be notice given to all Grantors.

Powers of Attorney. The various agencies and powers of attorney conveyed on Lender under this Assignment are granted for purposes of security and may not be revoked by Grantor until such time as the same are renounced by Lender.

Severability. If a court of competent jurisdiction finds any provision of this Assignment to be illegal, invalid, or unenforceable as to any circumstance, that finding shall not make the offending provision illegal, invalid, or unenforceable as to any other circumstance. If feasible, the offending provision shall be considered modified so that it becomes legal, valid and enforceable. If the offending provision cannot be so modified, it shall be considered deleted from this Assignment. Unless otherwise required by law, the illegality, invalidity, or unenforceability of any provision of this

Assignment shall not affect the legality, validity or enforceability of any other provision of this Assignment.

Successors and Assigns. Subject to any limitations stated in this Assignment on transfer of Grantor's interest, this Assignment shall be binding upon and inure to the benefit of the parties, their successors, and assigns. If ownership of the Property becomes vested in a person other than Lessor, Lender, without notice to Grantor, may deal with Grantor's successors with reference to this Assignment and the indebtedness by way of forbearance or extension without releasing Grantor from the obligations of this Assignment or liability under the indebtedness.

Time is of the Essence. Time is of the essence in the performance of this Assignment. **Waiver of Homestead Exemption.** Grantor hereby releases and waives all rights and benefits of the homestead exemption laws of the Staie of Missouri as to all indebtedness secured by this Assignment.

DEFINITIONS. The following capitalized words and terms shall have the following meanings when used in this Assignment. Unless specifically stated to the contrary, all references to dollar amounts shall mean amounts in lawful money of the United States of America. Words and terms used in the singular shall include the plural, and the plural shall include the singular, as the context may require. Words and terms not otherwise defined in this Assignment shall have the meanings attributed to such terms in the Uniform Commercial Code:

Assignment. The word "Assignment" means this ASSIGNMENT OF LEASE AND AGREEMENT, as this ASSIGNMENT OF LEASE AND AGREEMENT may be amended or modified from time to time, together with all exhibits and schedules attached to this ASSIGNMENT OF LEASE AND AGREEMENT from time to time.

Borrower. The word "Borrower" means Clinton Airport Association, Inc.

Event of Default. The words "Event of Default" mean any of the events of default set forth in this Assignment in the default section of this Assignment.

Grantor. The word "Grantor" means Clinton Airport Association, Inc.

Guarantor. The word "Guarantor" means any guarantor, surety, or accommodation party of any or all of the indebtedness.

Guaranty. The word "Guaranty" means the guaranty from Guarantor to Lender, including without limitation a guaranty of all or part of the Note.

Indebtedness. The word "indebtedness" means all principal, interest, and other amounts, costs and expenses payable under the Note or Related Documents, together with all renewals or, extensions of, modifications of, consolidations of and substitutions for the Note or Related Documents and any amounts expended or advanced by Lender to discharge Grantor's obligations or expenses incurred by Lender to enforce Grantor's obligations under this Assignment, together with interest on such amounts as provided in this Assignment. Specifically, without limitation, Indebt6dness includes the future advances set forth in the Future Advances provision, together with all interest thereon and all amounts that may be indirectly secured by the Cross-Collateralization provision of this Assignment.

Lender. The word "Lender" means LEGACY BANK & TRUST COMPANY, its successors and assigns. **Note**. The word "Note" means the promissory note dated April 26, 2024, in the original principal amount of \$80,000.00 from Grantor to Lender, together with all renewals of, extensions of, modifications of, refinancings of, consolidations of. and substitutions for the promissory note or agreement.

Property. The word "Property" means all of Grantor's right, title and interest in and to all the Property as described in the "Assignment" section of this Assignment.

Related Documents. The words "Related Documents" mean all promissory notes, credit agreements, loan agreements, environmental agreements, guarantees, security agreements. mortgages, deeds of trust, security deeds, collateral mortgages, and all other instruments, agreements and documents, whether now or hereafter existing, executed in connection with the indebtedness.

Rents. The words "Rents" means all of Grantor's present and future rights, title and interest in, to and under any and all present and future leases, including, without limitation, all rents, revenue, income, issues, royalties, bonuses, accounts receivable, cash or security deposits, advance rentals, profits and proceeds from the Property, and other payments and benefits derived or to be derived from such leases of every kind and nature, whether due now or later, including without limitation Grantor's right to enforce such leases and to receive and collect payment and proceeds hereunder.
